Mr. Howell told them in the accused's presence that she had called upon him, and said that she wanted a furnished house. Mr. Howell gave her a letter, and she visited a house at St. Kilda. When she reached the house she informed the servant that she had lost her purse, and on the strength of that the servant gave her a shilling. She returned to Mr. Howell, and, telling a similar story to him, received £2 6d.

Mr. Fenton: "It appears to me more like a case of lunacy."

Mr. Field Barrett (who appeared for the defense) said that some years ago she had a fall from a high place, and she attended her, said that at times she would suffer from the effects of that fall. There was no earthly reason why she should do such a thing as that charged against her, but she broke out in this most unaccountable way at times. Some four years ago she was before the St. Kilda Court for a similar thing. The bench accepted her mother as surety for her behavior. Since then she had been in no complaint except the present. If the Bench were to accept the mother as surety, the mother and brothers could keep a close eye on her. It would be commensurate with justice if the Bench would do that.

Mr. Pantoun: That would not stop her. It was more like the act of a lunatic.

The mother of the accused gave evidence which bore out Mr. Barrett's statement. The girl had a most comical turn of mind, and her brothers were most kind to her. She (the mother) would pay back every shilling she got. The accused was then discharged.
