There was no desire on the part of the police or the bench to have the young woman sent to gaol, and the Salvation Army authorities were asked to take her in hand. In the meantime the Hospital authorities were communicated with, and it was agreed that the accused, who appeared very ill, should be admitted into the Hospital. On this understanding the Salvation Army authorities were not troubled any further. Later in the afternoon when the unfortunate woman was taken to the Hospital, Dr. Gardiner refused to admit her as she was suffering from an ailment which precluded her being taken in. Once more the accused was brought before Mr. Johns, P.M., and she was sent to gaol for a month.
