ATTEMPTED SUICIDE OF A WOMAN.

A woman named Ellen Buott, a resident of Jeffcott-street, West Melbourne, was taken to the Melbourne Hospital shortly after 4 o'clock yesterday, suffering from the effects of poisoning, by iodine and alcoholism. Dr. Evans, who admitted her, applied the usual remedies, and the patient was speedily relieved and is now considered out of danger. The woman's husband, who is a cabman, is an inmate of the Hospital, suffering from a broken leg. The attention of Constable Thomson, of King-street, was called to Mrs. Buott in a house occupied by Mrs. Hawkins, in Little Lonsdale-street. From inquiries he made he concluded that the unfortunate woman had been driven to make the attempt upon her life by the stress of poverty and ill-health.
