ESCAPE OF REFORMATORY GIRLS.

Some excitement was created at Coburg last night when it became known that three of the inmates who had been drafted from the girls reformatory at Pentridge to the Woodland Home at South Preston had succeeded in making their escape. The inmates of this Home are selected to be specially trained for domestic servants, and are chosen for their good behavior while undergoing the more rigid discipline of the reformatory. They are under the charge of Miss King, one of the most experienced attendants in the school, and every latitude consistent with proper discipline is allowed them. Last evening, however, the following inmates cleared:—Amelia Mary Beatt, 15 years of age, formerly of Bairnsdale; Rebecca Scanlan, 14 years of age, formerly of Sale; and Caroline Snellback, 14 years, from Ballarat. The girls are dressed very neatly in grey winsey, and wore white straw poke shaped hats, trimmed with white ribbon. The girls, taking advantage of the attendants being engaged, scaled the fence surrounding the home and bolted. The matter was at once reported to Mrs. Bloxham, the matron of the Reformatory at Pentridge, who promptly communicated with Sergeant Bass, of the Coburg police, and the telephone was speedily set in motion, and the escape communicated to the surrounding police stations; but up to noon to-day nothing had been heard of the capture of the young runaways, and it is feared that they are being harbored by some of the criminal class of women in the city. It is thought the girls went in the direction of Preston or Northcote on quitting the Home.
