TO SUE INSPECTOR McPHERSON: My husband is a solid^{RH}er and he is at the front. I remember Sunday morning the 3rd June last. I was in bed when I heard quarelling. That would be about 20 to 2 in the morning. I got out of bed and looked through the window and saw four men opposite my window on the opposite side of the street to my house. I did not know any of them. I went back to bed. After being in bed I heard a revolver shot, and then in about the space of two seconds I heard three in succession; then there was another space and I heard another; that was five altogether that I heard. In consequence of hearing the shots I came out. I looked out and saw a man lying on the footpath down near the Mission. about 50 yards from my gate on my side. I saw someone go over to him and speak. A man went over to him - to his right hand side and said - "Jack, Jack", and knelt right down; then he ran out on the road and referred to two other men near the Israelite's Church. He said "It is no use - (using a horrible expression) - fooling round here; something will have to be done", and with that he ran towards Gertrude Street. I saw the two men on the opposite side and the bigger man of the two said - "It is no use, he is shot now, you had better walk away, the police will be here soon." He repeated that twice. I could not hear what the smaller man said. I do not know where they went but they went towards Hanover Street. I saw a hansom cab come to the spot with this man who had walked away before the cab came. The man that ran towards Gertrude Street jumped out of the cab at the corner of James Street and Fitzroy Street, and said - "No, down here", and the

driver drove up to where the man was lying. There were some women there but I do not know who they were. The man that I saw running towards Gertrude Street came back with the hansom cab. I could not tell you if he put the deceased in the cab; there was such a crowd around that I could not see. Then I heard a policeman call out - "Grab that horse, Cooper." Then a constable got up in the hansom cab and I went inside then. I think the lights were ~~on~~ burning in the cab. I do not know where the man who ran up towards Gertrude Street came from. The man had been lying there for fully five minutes before anyone came to him, and he was the first to come to him.

TO THE CORONER: That was fully five minutes after the shots had been fired. In the meantime I was standing at the fence in front of my place. I looked out just after I heard the shots and I only saw the two men over at the Israelite's Church gate, and then this man - I do not know where he came from. I was watching the men on the opposite side - he had his hat in his hand.

TO SUB INSPECTOR McPHERSON: On the morning of the 3rd June last I was in Victoria Parade, by some supper rooms - No, about 140.

TO THE CORONER: I had a hansom cab there.

TO SUB INSPECTOR McPHERSON: I was in Victoria Parade, near St Vincent's Hospital. While I was there a man came up to me. I identify the man Johnson now standing in Court as the man who came up to me. He wished to engage the cab. He asked me if I was engaged. He said "are you engaged", or something to that effect. I said that I had another appointment and that I could not possibly do it, but he insisted. He said "You must come along to take a man to the hospital; he has got a bullet in his head." When I heard that I went immediately. I drove him down Fitzroy Street to the corner of Fitzroy and James Streets. He stopped me about 10 yards before he came to the right spot. Nothing was said - he just said to pull up. He got out of the hansom near where a man was standing or being supported by 4 or 5 women on the street. I heard something said by the women about "getting even". I do not know with whom that would be in regard to getting even. The attitude of the people about there towards the man Johnson was that they did not seem too friendly in my opinion. The injured man was put in my cab right away. There was no light inside the cab. I was just driving off when the police rushed up and stopped the cab. I went to the police station afterwards. I was not present in the office at the station; I was outside. I afterwards took the man to St Vincent's Hospital.

TO SUB INSPECTOR McPHERSON: At 2.30 a.m. on the 3rd June last I was on duty in Brunswick Street; Fitzroy. I heard cries of "Police" coming from the direction of Hanover Street and I went to the corner of Brunswick Street and Hanover Streets. On the way there I was joined by Constable Cooper. He joined me in Brunswick Street. I saw a hansom cab at the corner of Fitzroy Street and Brunswick Place. It was being driven away and I stopped it and on looking inside I found two persons, one of whom was bleeding freely from the head. The man Johnson now standing in court was the other one. The deceased Cleary was bleeding freely from a wound on the left side of the head, above the left ear. I said to him "Who shot you"? He said @ "I am not shot, I only fell down." Before that I heard a woman say "He is in the cab." That was prior to my looking in the cab. I took the hansom cab and the occupants to the Fitzroy Watch-house. I took the injured man out of the cab at the watch house and took him into the office. He was apparently under the influence of drink but otherwise he was quite conscious and rational. While he was at the lockup I ascertained his name and address. He put his hand in his trouser pocket and drew some silver out and handed it to Johnson. He then put his hand in the inside pocket of his coat or vest and drew out a roll of notes and handed that also to Johnson, at the same time saying - "Take this or these bastards will get it." By that he meant the police. I did not count the money. I conveyed the injured man to the hospital and he was admitted by Dr. Maher. I re-

there while the Doctor examined him. The Doctor examined the wound while I was there and said that the deceased was suffering from a bullet wound in the head. Johnson was present at that time. Deceased was asked later on how he received his injuries. Constable Mafferzona and I went to the hospital later - about three o'clock I think it would be.

We went to the ward where he was lying and Constable Mafferzoni said to deceased, "Do you know me"? He said "Yes." Constable Mafferzone said "How did you get hurt", or something to that effect. He said "I do not know." Constable Mafferzoni said "Where were you"? He said "I do not know." Constable Mafferzone again said "Who shot you?" He said "You know I would be the last one to give any one away." He refused to say how, where or when he was shot, or as to what happened.

My attention was attracted by three shots being fired. I then ran along Webb Street to Young Street and I met Constable Riley in Brunswick Street. I saw a hansom cab when we had proceeded from Brunswick Street to Fitzroy Street. I went with the cab to the watch house. I took Murry and McDay to the watch house also. Constable Riley took the injured man to the hospital

RM TO THE ~~GOVERNOR~~ CORONER: I only heard three shots; I heard one fired and then two in quick succession a few seconds after the first one. I heard no more after that. I should say it would be about 200 yards from the scene where the man was found to where I was. There may have been more shots fired; you could not tell where the sound came from from where I was.

TO SUB INSPECTOR McPHERSON: At one a.m. on the 3rd June I was round the corner from the Cyclorama in Fitzroy Street, having supper. I was with a stranger. After we had supper we walked down Fitzroy Street, and while walking along Fitzroy Street I heard four shots fired. I continued along the Street and I saw a man lying half in the pavement and half in the gutter. From where I was when I heard the shot fired to where I found the man lying in the street I think it would be between 100 and 150 yards. I did not see a woman there then. There was no one about at all when I saw the man. I struck a match and had a look at him and I found that he was bleeding from the head and face. Then I went down to the corner and called out for the police. I stopped at the corner and sang out. It was a junction and the police came to there; then I went back with the police to where the man was lying. The man at this time was either in a hansom cab or getting in; I am not too sure but I fancy he was in it. When I first saw the man he was not conscious. There was a man passed me when we were coming down Fitzroy Street. I could not say whether it is Mr Johnson, who is now present in court. It was very dark at the time. I saw a man running towards Victoria Parade. Some time after a cab came on the scene. It came during the interval while I was away getting the police. I do not know any of the people about there. There were a number of women about while he was being taken away in the cab/

Mrs. Henderson, Mrs. Glazebrook, Mr. and Mrs. Cleary, Mrs. Sullivan, Mr. and Mrs. Dunn, Mr. Mitchell, and Mr. Johnston.

I do not know a man named "Snowey". I do not know a man named "Cudmore". There were two men who called early to see Mr. Dunn. They were in the front room when I walked into the front room. It was early when I saw the two men there. I could not describe the two men because they had their hats on. They were both stout men. It was a musical evening, singing and playing the piano. There was nothing else. I had a small barrel of ale. There were no other refreshments. Deceased's wife came to the house somewhere between 9 and 9.30. She came with Mrs. Sullivan. The deceased was there about 9 or 9.15. I remember deceased coming. He came with Mr. Johnston at between 9 and a quarter past. There was no unpleasantness during the evening. I did not hear anyb shots fired. I first heard that Cleary had been shot on the Sunday morning. Mr. Johnston came in early in the morning when my servant was getting breakfast ready. He told the servant and the servant told me. Cleary left my place somewhere near 12 midnight. I did not see him going out the front door. I was out in the back yard talking to Mr. Johnston when Cleary went out. I was not in the front room. Johnston went back into the front room. It could

He asked me did I know a man named Cudmore, and I said - "No, I never knew his name till you mentioned it to me". Then he abused and he said he had known me for 20 years, that I had been dying, and that it was a pity I was not dead. I have suffered from my nerves. I said - "There were respectable people in my house and I do not want to mention their names." I went down to the watchhouse and I said the same there. I have mentioned the respectable people's names to-day. The names I have given are all those people who were at my house that night.

TO THE CORONER: I last saw Johnston between 12 and a quarter past. They had not all gone then. Johnston went out of the place by himself. The deceased Cleary had gone before that. All the other men except Mr. Ryan and Mr. Mitchell had gone by that time, and Mr. and Mrs. Dunn, who were in the house. They were boarding with me.

On the 3rd June of this year, in company with Detective Hawkins, I saw deceased at St. Vincents Hospital. He was in bed and had his head in bandages. Hawkins said to him - "You know me. Cleary"?--He said, "Yes." Hawkins said, "What happened to you?" He said, "I was shot". "I do not know who done it or where it happened. I had some beer at a grog shop but I do not know where that was or who keeps it".

Since that date Detective Hawkins and myself have interviewed all the witnesses that could throw any light on this matter and statements have been taken from them and placed before this Court with the exception of Harry Dunn and Rae Dunn. We have been unable to locate Harry Dunn. He was living at 237 Fitzroy Street, Fitzroy, but he and Rae Dunn have left there. Rae Dunn was seen last night by Plain Clothes Constable Appleby and instructed to be here to-day. She passed the remark that she would please herself, and she did not think she would be here. Early on Sunday morning of the 3rd June, I visited the locality where the shooting took place, and in front of St. John's Mission Hall, at the corner of Brunswick Street, Brunswick Place and Fitzroy Street, I noticed a pool of blood where the deceased was alleged to have been lying. And on the following morning, Monday, I noticed a bullet hole freshly made directly opposite where the pool of blood was, and in the yard of the church I found this bullet which I produce. I made a rough sketch of the locality, showing the place where the party was held on that night, at the witness Mrs. Jones' place. Also the Mission Church where the deceased

TO SUB-INSPECTOR McPHERSON: On the evening of 2nd June last - which was on a Saturday night - I went to the Fight with two chaps, two Sydney boys. One was named Pat O'Connell but I do not know the name of the other. He was a friend of Pat's. He was not called Snowy. I remained at the Fight until it was about over and went home at about 11 o'clock to Fitzroy St. The two men who went to the fight with me did not come home with me. I went to Mrs Vern's place in Fitzroy Street, where there was a party. Quite a number of people were at the party. I just knew them through coming to the house - I was just a stranger staying there - I was boarding there. There were quite a number of men in the front room. The party broke up about one o'clock. I was there all that night in the house from 11 p.m. on. I did not see Cleary leave the house; they were not all sober. I stayed there that night. I first heard on the Sunday morning that Cleary had been injured. I did not hear any shots fired during that night. On the Sunday morning a servant employed in the house told me that Cleary had been shot. I do not know a man named Cutmore. I live in Carlton now. I was not warned to attend this Inquest last week by the Police. I do not know Sergeant Appleby. I did not know the date on which the Inquest would be held. I left the place where I was living. I think I informed quite a number of people where I was going. I did not tell the people at the house where I was boarding that I was going to live in Carlton. I never left my work where I had been working. When I came into the city with the two men from the Fight, I left them in Bourke Street. I had seen

one of the men before; I had met the other one before but I did not know his name; he was a friend of the other man's.

TO THE CORONER: They came to see me at Mrs Jones' place at halfpast seven on the Saturday night. They did not come there after I arrived home from the Dight. I am sure of that. I do not know Cutmore or a man called Snowy. It is not true that he went away with me from this party. I work at 213 Berkely Street, Carlton, for a man named Young. I have been there for two months and I am working there still; since this trouble took place I have still been working there. I am living at 151 Barry Street, Carlton. I have been living there since I left Fitzroy Street. I have not seen either of the men since Cleary's death.
