Their address will be c/o Mr W O'Brien, Pine Creek Bellenger & S^r. Mrs D says she is not very well acquainted with Mrs M^cParland who is her sister-in-law. She had a satisfactory explanation to offer as to why she had not enquired about her children since August 98. She had three children with her & they were very tidy & appeared to be well cared for. She herself was very tidy & had quite a respectable appearance at 9. 15. 11/06. During the last two years Mrs Doyle had been living at Barlisle River and she bears a good character except that she cannot resist the temptation of partaking of intoxicating liquors when the opportunity presents itself. Before leaving Colac she was apparently under the influence of liquor.
