Executor thereby nominated having duly renounced
Probate thereof as by act of Court appears the said
August Christian Huenerbein having been first duly
sworn that he will well and truly collect and
administer according to law to the best of his knowledge
and ability the property lands and hereditaments
goods chattels and credits of the said deceased at
the time of his death which at any time after
shall come to the power or control hands or
possession of him the said August Christian

Thuenen as his Executor or of any other person or persons for him that he will make or cause to be made a true and perfect inventory of all and singular the property lands and hereditaments goods chattels and credits of the said deceased which shall have come to the hands possession or knowledge of him or to the hands or possession of any other person or persons for him and the same so made will sign with his proper handwriting and will exhibit and deposit or cause to be exhibited and deposited the same inventory in the office of the Master in Equity within three Calendar months next ensuing the Order granting Probate and further that he will make or cause to be made a true and just account of the administration of the Estate which he has undertaken as to his receipts and disbursements and as to what portion is retained by him and what portion remains uncollected and the same so made will sign with his proper handwriting and will exhibit and deposit or cause to be exhibited and deposited the same account in the said Office of the Master in Equity within fifteen Calendar months next ensuing the Order granting Probate and that the said Charles Albert Frederick Slater deceased left no Real estate in this Colony so far as he the said August Christian Thuenen knows and believes but he left personal estate in the said Colony not exceeding in value as he the said August Christian Thuenen believes the sum of Seven thousand pounds.
