Melbourne Dealer Deceased

We Louis Charles Gerschel of Grattan Street
Carlton in the Colony of Victoria Merchant
and George Fischer of Solimont Street Solimont
in the City of Melbourne aforesaid Gentlemen
severally make oath and say:

1. That the abovesaid Robert Wiener
late of the City of Melbourne aforesaid Dealer
departed this life on the Third day of
July in the year of Our Lord one thousand
eight hundred and seventy eight
2. That he has left a will bearing date
the fifth day of April in the year of Our
Lord one thousand eight hundred and seventy
~~eight~~ ^{seven} which is hereto annexed marked
A and thereby appointed us the said Louis
Charles Gerschel (in the said will called
Louis Gerschel) of Carlton aforesaid and George
Fischer of Solimont aforesaid Executors thereof
and we verily believe the said will is
unrevoked
3. That the said will was executed in the
presence of Louis Gerschel of Carlton aforesaid
and F. Wilhelm Krüger of South
Australia
4. That the said deceased had at the time of
his death personal estate in the said Colony

under the value of Two hundred pounds.
but was possessed of no Real Estate in the said
Colony

5. That we will pay all the just debts
and legacies of the said deceased so far as
the property left by him will extend and the
law bind us so to do

And I the said Louis Charles Gerschel
for myself further say :-

6. That my name is Louis Charles Gerschel
and I am the person appointed Executor
under the said will by the name Louis Gerschel

The above named Deponents Louis
Charles Gerschel and George
Fischer were severally sworn
at the City of Melbourne in the
Colony of Victoria this 31st
day of July A.D. 1878
