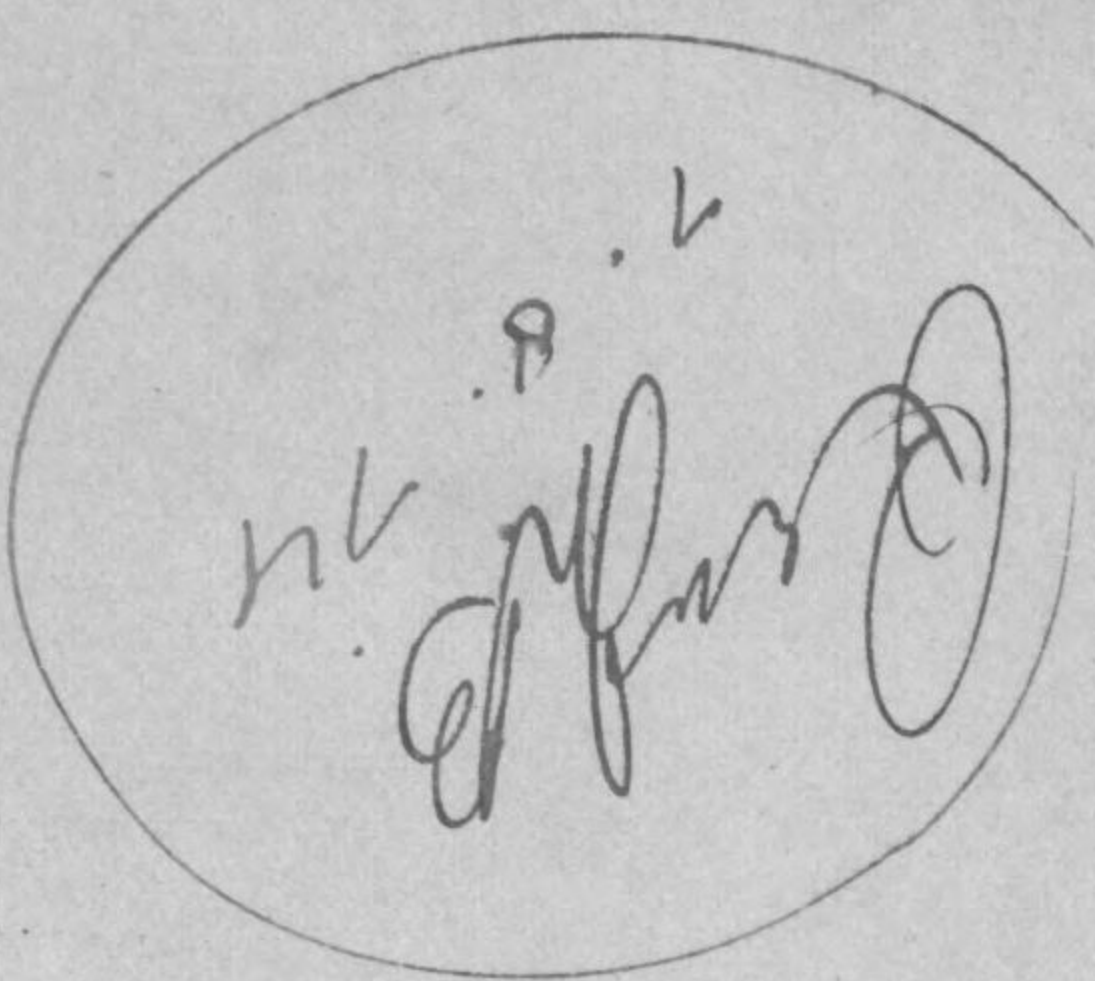

I was working at Richmond yesterday morning. I observed the deceased man whom I did not know, in the street. I saw him go to Chester's house. I saw Chester put him out of the gate and leave him there standing against the fence. There was no blow struck. Chester used no more force than was necessary to put deceased off the premises. In less than a minute I saw deceased leave hold off of the fence and fall backward on the path. He did not get up. In about five minutes a man went up to him and put him against the fence. I saw no more of him. I think deceased was drunk. His head appeared to me to strike the cutb stone when he fell.

James Patrick Bryan
on his oath saith, I am a *fully qualified medical practitioner*
residing at *Richmond*

I was sent for yesterday morning to see the deceased John Albert Drogitt. I found him dead - having been dead apparently about an hour.

I have made a post-mortem examination of his body. Externally there were no marks of injury - except on the back of the head there was a tumor with a small enclosed wound.

Under the scalp corresponding with the wound there was extravasation of blood. The dura mater was very adherent and on removing it the blood flowed very freely - more especially from the region of the wound. There was no fracture of the skull. There was effused blood beneath the arachnoid, over a considerable surface of the brain. There was also some appearance of probably old effused lymph. The brain was vascular throughout.

The lungs were both emphysematous in front. They were congested behind. The left pleural cavity contained about three ounces of serum. The heart had a thick coating of fat.

The heart was somewhat enlarged - its walls. The left ventricle was somewhat enlarged - its walls thickened. The right ventricle was exceedingly thin. The valves were sound.

The liver was very much enlarged and somewhat friable.

The Stomach contained a small quantity of thin purinous fluid. Its lining membrane seemed congested in patches. There was an alcoholic odor present. There were no signs of poison. The intestines were healthy.

The cause of death was extravasation of blood on the brain. This came apparently from rupture of the superior longitudinal sinus. It appeared to have been ruptured at the time the injury occurred to the back of the head. The wound and swelling were such as might have been caused either by a blow from a blunt instrument, or by a fall on a stone or any other hard projecting body. The organs of disease were those of a man in the habit of drinking. The vessels of the brain would be more likely to give way from injury, than those of a man of temperate habits. I am of opinion the death was certain. Medical attendance would have been of no use.
