Bay Street Brighton in the State of Victoria retired solicitor
make oath and say :

1. That I am seeking to obtain probate of the will of the
above named Thomas Henry Walton deceased pursuant to the
leave reserved in the grant of probate made on the fourth day
of September One thousand nine hundred and nine and I am of
the full age of twenty one years.
2. That the said deceased died on the twenty third day of
July Onethousand nine hundred and nine leaving his last will
and testament bearing date the fifth day of April One
thousand nine hundred and six which is as I believe unrevoked
and thereby appointed me this deponent and Ada Mary Walton of
51 Delbridge Street North Fitzroy in the said State executor
and executrix thereof.
3. That such will was duly proved by the said Ada Mary Walton
the said executrix on the fourth day of September One thousand
nine hundred and nine leave being reserved to me this deponent
the executor named in the said will to come in and prove the
same.
4. That produced and shown to me at the time of my swearing
this affidavit and marked "A" is the probate copy of the true
last will and testament of the said Thomas Henry Walton
deceased as I verily believe.
5. That the said deceased left real estate in the State of
Victoria not exceeding in value the sum of Five hundred and
sixty pounds and personal estate in the said State not exceeding
in value the sum of Two hundred and sixty six pounds two

shillings and five pence.

6. The said Thomas Henry Walton deceased was at the time of his death a British subject by birth.

7. That if I obtain probate I will well and truly collect and administer according to law to the best of my knowledge and ability the property lands and hereditaments goods chattels and credits of the said deceased at the time of his death which at any time after shall come to the power or control hands or possession of me as his executor or of any other person or persons for me that I will make or cause to be made a true and perfect inventory of all and singular the property lands and hereditaments goods chattels and credits of the said deceased which shall have come to the hands possession or knowledge of me or to the hands or possession of any other person or persons for me and the same so made will sign with my proper handwriting and will exhibit and deposit or cause to be exhibited and deposited the same inventory in the office of the Master in Equity within three calendar months next ensuing the order granting probate pursuant to leave reserved and further that I will make or cause to be made a true and just account of the administration of the estate which I have undertaken as to my receipts and disbursements and as to what portion is retained by me and what portion remains uncollected and the same so made will sign with my proper handwriting and will exhibit and deposit or cause to be exhibited and deposited the same account in the said office of the Master in Equity within fifteen calendar months next ensuing the order granting probate pursuant to leave reserved.
