Colony of Victoria Mexican Deceased
I Ellen Howe of Gore Street Colling-
wood in the Colony of Victoria the
Widow and Sole executrix of the last
Will and testament of the said Joseph
Percival Howe deceased make Oath and
Say - That the said Joseph Percival
Howe late of Gore Street Collingwood
aforesaid, Mexican departed this
life on the Ninth day of November
A D 1859.

That I believe the annexed
paper writing bearing date the seven-
teenth day of September A D 1859
to be the true last Will and testament
of the said Joseph Percival Howe late
of Gore Street Collingwood aforesaid
Deceased which is as I believe un-
revoked and thereby appointed me
the said Ellen Howe Sole Executrix thereof.

and legacies as far as the property
left by him will extend and the

Musician being Weak in Body but of Sound
and disposing Mind Memory & Understanding
Praise be God for the same do make public
and declare this my last Will and Testament
hereby revoking all other Will or Wills
by me at any time heretofore made =
First I direct that all my Just debts and
Funeral expenses be fully paid and satisfied
and Subject thereto. I give and bequeath
all my Household Furniture Good Chattels
and Effects Money's Securities for Money
and all other Personal Estate of which I may
die possessed of and entitled to unto my
dearly beloved Wife Ellen Store otherwise
Clothing to and for her own sole and separate
use and benefit and free from the debts or
Engagements of any Husband she may after
my decease marry And Whereas by
Indenture bearing date the thirtieth day
of September One thousand eight hundred and fifty
four I am now seized of a & otherwise entitled
to all that piece or parcel of Land situate
lying and being in the Parish of Outpawpaw
in the Colony of Victoria being part of portion
number eighteen of the said Parish & comprising
lots

I sold to the Mayor Aldermen Councillors and Citizens of the City of Melbourne To give and devise the same respectively and every part and parcel thereof together with all buildings and improvements erected thereon unto my said dearly beloved Wife Ellen Hore upon Trust and to and for the uses intents and purposes hereinafter mentioned and expressed. That is to say to the use of my said Wife until my Children Rufus Henry Hore and Lauretta Hore or the Survivor of them shall attain the age of Twenty One years and it is my Will that in the meantime my said Wife shall receive the Rents Issues and profits of all my said Freehold Premises and apply the same towards the Maintenance Education and Support of my said Children and also towards the Maintenance and Support of my said Wife. And I Will and direct that my said Wife shall on my said Children attaining the age of Twenty One years as aforesaid Set up and Sell either by Private Sale or Public Auction. All my said Freehold Premises for the best

and Highest Price that can be had for the
Same and that the proceeds thereof be
equally divided between my said Wife
Ellen Hore and my said Children Rufus
Henry Hore and Lauretta Harriet Hore
Share and share alike to and for their
own sole and Separate use and benefit
and as to the Shares of my said Wife
and daughter that they shall have
and receive the Same absolutely free
and clear from the Control Debts or
Engagements of any Husband they or
either of them may intermarry with
And in the event of the Death of my said
Wife or either of my said Children before
they shall have attained the age of
Twenty one Years as aforesaid then and
in such Case it is my Will and
Desire that the Share or Shares of any
or either of them so dying shall be
equally divided between the Survivor
and if there shall be but one then to
Such Survivor alone to and for his or her
own sole and Separate use and benefit.

but if my said Wife should happen to be such
Survivor then and in such Case it is my
Will and desire that no part of my said
Freehold Property should be sold but
that my said Wife should have take and
receive the Rents Issues and Profits of
my said Freehold Property for and during

clear from the Debts Control or Engagements
of any Husband she may after my Decease
intermarry with. And from and after
her Decease I will and desire All my
said Freehold Property to Such person
